#### Основни подаци

др Ђорђија Петкоски је рођен 11. марта 1949. године у Глобочици, данас Република Македонија. Основне и магистарске Северна студије је завршио Електротехничком факултету Универзитета у Београду (1972, односно 1974. године). Свој први докторат је стекао из области комплексних система ("Примена еметоде за одређивања линеарног регулатора са структурним оганичењима") на Електротехничком факултету Универзитета у Београду 1978. године, а други из области стратешког управљања предузећима ("Управљање системима у подручју економије у условима неизвесности") на Економском факултету Универзитета у Загребу 1991. године. Наредне године је на Кенедијевој школи државног управљања Универзитета Харвард (Kennedy School of Government, Harvard University) завршио и мастер студије јавне администрације-економије (Master in Public Administration-Economies Transition/Agro-Business/Environment). in Такође je завршио специјализацију из извршног развоја и корпоративних финансија (Executive Development/Corporate Finance) на Пословној школи Универзитета Харвард (Harvard University Business School).

У време док је радио на универзитетима у Србији, био је истраживач приправник на

Електротехничком факултету у Београду (1972-1974), а од 1974. до 1990. године је на Факултету техничких наука Универзитета у Новом Саду био у наставним звањима асистента (1974-1978), доцента (1978-1981), ванредног професора (1981-1984) и редовног професора (1984-1990). У том је периоду (школске 1979/1980 године) био гостујући истраживач у Лабораторији за системе одлучивања и информација (Laboratory for Information and Decision Systems) Масачусетског института за технологију (Massachusetts Institute of Technology), а као Фулбрајтов стипендиста је био гостујући истраживач на Универзитету Харвард (Harvard University) школске 1990/1991. Од 1992. до 2011. године радио је у Светској банци (World Bank) на различитим високим позицијама. Господин Петкоски је данас предавач и старији сарадник Вортон школи Универзитета Пенсилваније и оснивач Глобалне конкурентости, развоја и вођства (Global CDL - Competitiveness, Development and Leadership). Активни је консултант Светске банке, Међународне организације рада (International Labour Organization, ILO), Организације америчких држава, националних влада и других институција.

# Објављени научни радови и научна саопштења на међународним скуповима

Потпунији списак књига, поглавља у књигама, научних радова и пројеката професора Петкоског дат је у прилогу овог Реферата. Непотпун приказ у бази података Research Gate говори да је проф. др Ђорђија Петкоски објавио 40 библиографских јединица које су цитиране 461 пут, уз h-index 8. Треба при томе имати у виду да је г. Петкоски највећи део своје каријере провео у неакадемској средини, бавећи се друштвеним наукама, а да су каснији послодавци, попут Универзитета у Пенсилванији, пре свега имали у виду и ценили његову целокупну биографију и знања, а на суве и искључиве научне параметре.

# Међународна научна репутација

Господин Петкоски је током готово двадесет година свог рада у Светској банци, од 1992. до 2011. године, био на различитим високим позицијама, укључујући и место шефа Програма за пословање, конкурентност и развој. Током свог мандата у овој организацији, бавио се највише корпоративним и стратешким управљањем, иновацијама, питањима конкурентности и одрживог развоја на глобалном, националном и корпоративном нивоу. За време мандата у Светској банци, стварао је и руководио бројним глобалним пројектима, а био је један од оснивача тима који је водио програме Светске банке за реструктурирање предузећа у источној Европи, бившем Совјетском Савезу, Африци и Кини, као и пројекте реформисања државних предузећа и унапређења функционалности извршних власти у областима корпоративног управљања за привредне руководиоце, владине званичнике земаља, али и чланове академске заједнице земаља бившег Совјетског Савеза, Источне Европе и Африке. Бавио се и програмима који су за циљ имали развој пољопривреде, инклузивне пословне моделе у тржиштима у развоју, као и борбу против корупције у земљама Блиског Истока и Северне Африке. Допринео је осмишљавању и спровођењу програма лидерства у развоју одрживог развоја за више менаџере Светске банке и Међународне финансијске корпорације (International Finance Corporation, IFC), перспективне пословне руководиоце и владине званичнике, који је спровео Универзитет Кембриџ (Cambridge University). Такође је радио на дизајну извршног програма Масачусетског института за технологију о одрживом развоју за руководиоце мултинационалних компанија и владине званичнике земаља у развоју.

О његовој међународној репутацији можда најбоље говори чињеница да је господин Петкоски данас предавач и старији сарадник на Вортон школи Универзитета Пенсилваније као и директор једног од центара (Зиклин центар за истраживања пословне етике Вортон школе Универзитета Пенсилванија, Carol and Lawrence Zicklin Center for Business Ethics Research, the Wharton School, University of Pennsylvania), у овој школи. Ђорђија Петкоски је и оснивач Глобалне конкурентости, развоја и вођства (Global CDL- Competitiveness, Development and Leadership), активни консултант Светске банке, Међународне организације рада (International Labour Organization, ILO), Организације америчких држава, националних влада и других институција. Радио је, као консултант, са преко 100 мултинационалних компанија у широком спектру индустрија, укључујући IT и индустрије високе технологије, индустрије производње и прераде пољопривредних производа, индустрије хране и пића, лепоте и хигијене, компаније из области енергетике и рударства. Привредни ентитети у којима је радио као консултант укључују и SAP, Nestle, Mars Co, PepsiCo, L'Oreal, Firmenich, Olson Zaltman, CEMEX, Siemens, Britannia, UNICA, DSF, Tetra Рас итд. Највећи део примењених истраживања др Ђорђије Петкоског јесте посвећен одрживом развоју, односно ESG концепту, а у новије време се бави и укључивањем одговорне примене вештачке интелигенције у корпоративне стратегије и организационе промене које подстичу одрживи развој.

Петкоски је водио и стварање Пословне алијансе за глобалну алијансу за побољшану исхрану (Business Alliance for the Global Alliance for Improved Nutrition, GAIN), вишедонаторске иницијативе уз подршку Гејтс фондације (Bill & Melinda Gates Foundation), Светске банке и многих водећих мултинационалних компанија. Петкоски је од 2014. ко-председавајући иницијативе Идеје за акцију (I4A) Светске банке и Зиклин центра за истраживања пословне етике Вортон школе Универзитета Пенсилванија, платформе која талентованим младим људима широм света пружа прилику да преузму активну улогу у обликовању глобалних развојних циљева, са тежиштем на финансирање развојних пројеката и ангажовање корпоративног сектора у њима. У 2020. години I4A иницијатива је примила 4.100 пријава, са око 10.000 чланова тимова из 142 земље и територије. Од 2015. године регистровано је више од 7.000 тимова, са преко 21.000 чланова. Од 2017. је ко-водитељ Иницијативе SGDs&Her, платформе за подршку женском предузетништву кроз стварање микрои малих предузећа, а коју су основали Светска банка, Програм уједињених нација за развој (United Nations Development Programme, UNDP), Организација Уједињених нација за права жена (UN Women) и Зиклин Центар. У време пандемије корона вируса, покренуо је 2020. програм "Предузетнички одговор на ковид 19-Иницијатива за стварање капацитета за борбу против ковида 19 у Африци: Идеје и иновација младих предузетника" ("Entrepreneurial Response to COVID-19 Initiative – Building Capacity to Combat COVID-19 in Africa: Ideas and Innovations from Young Entrepreneurs").

# Предлог Комисије

Комисија поготово констатује да са једне стране ово ангажовање, у складу са договором који постоји са др Петкоским, не захтева никаква материјална средства факултета, а са друге стране пружа могућност укључивања др Петкоског у рад не само Хемијског, већ и других факултета и преношења знања студентима целог Универзитета (у складу са Правилником о допуни правилника о условима и начину ангажовања гостујућег професора на Универзитету у Београду, "Гласник Универзитета у Београду" бр. 241/22), која нису искључиво академска, већ се тичу и реалног сектора, у областима које су савремене, попут одрживог развоја и вештачке интелигенције.

Имајући све написано у виду, Комисија са задовољством предлаже ангажовање др Ђорђију Петкоског, предавача и старијег сарадника Вортон школе Универзитета Пенсилванија (Wharton School, University of Pennsylvania), као гостујућег професора (Visiting Professor) на Универзитету у Београду-Хемијском факултету.
